DVR Office's Re-opening

All DVR Offices will be open July 1, 2021, with a limited staff.

All employees of DVR must wear a mask while in the building.

All members of the public must wear a mask while in the building, regardless of if you are fully vaccinated or not.

All members of the public must utilize the DVR process Dr. Owl, prior to entry into the building and wait for the ok from the program. Instructions are on the table near every entry point.

Entry into the DVR office is limited to the client only, unless otherwise needed by law or disability, the client may then have one person with them as needed, the person entering with the client must also follow all DVR process' and wear a mask.

Anyone who cannot wear a mask due to a medical condition, will be scheduled for a virtual appointment with a counselor.

The safety of the public and our staff is of the utmost importance to DVR, we retain the right to refuse service to anyone refusing to wear a mask in our facility or refusing to follow our entry process.

Welcome to DVR

To ensure that all safety protocols are followed, any person(s) entering the building must follow DVR process'.

If you have an appointment, please call the number below to check in, a member of the DVR staff will come to escort you in for your appointment.

If you do not have an appointment please follow the check in process at the entrance, and our staff will get you an appointment for a later date or set up a virtual appointment for you.

As you enter the building, you will find that we have a table set up for the public with hand sanitizer and masks if you need one.

You must sign in with our Dr. Owl application, you may use your cell phone and scan the QR code or fill out the hard copy questionnaire on the table.

If you answer yes to any of the questions on Dr. Owl, you will not be allowed entry into the facility, you must call to reschedule your appointment virtually.

You must always wear a mask in the building, no exceptions. If you cannot wear a mask, you will be asked to leave and reschedule your appointment virtually.

Entry into the DVR office is limited to the client only, unless otherwise needed by law or disability, the client may then have one person with them as needed, the person entering with the client must also follow all DVR process' and wear a mask.
