## **COVID-19, Return to In-person Learning, and Your Student's IEP**

By April 5, 2021, all schools in New Mexico are to be open for in-person learning, observing COVID-safe practices. Families also may choose to remain in remote learning for the remainder of the school year. Whatever your family decides, there are some questions that will likely need to be addressed in your child's Individualized Education Plan ("IEP"). This is true whether you or the school convenes the IEP team or there is a written amendment to the IEP. While DRNM cannot guarantee that the resources listed below will resolve any particular issue, they may help you to better understand your student's rights and what can be done if you feel they have been violated.

You can ask that these questions or requests be answered and documented in the Prior Written Notice of the IEP.

#### If the student is returning to in-person learning,

- How is that transition going to be supported by the school? Are there social emotional or behavioral needs that are going to need to be addressed? *See* https://www.copaa.org/page/ReOpening
- What new/additional accommodations or modifications are needed for the student to attend in person and observe COVID-safe practices? For example, is the student able to wear a mask, or are there alternatives that can be explored? Is there troubleshooting that needs to be done concerning social distancing? ### If the student is remaining in remote learning,

So you can ask the IEP team to consider:

- What decline in skills or lack of progress has the student suffered in the past year? How are the student's present levels of performance going to be assessed? *See* FAQ, **Providing a Free Appropriate Public Education (FAPE) through a Distance Learning Platform during a Closure to Normal School Operations due to the Coronavirus (COVID-19) Pandemic 2020,** <u>https://webnew.ped.state.nm.us/wp-content/uploads/2020/04/Special-Education-FAQ-Final-4-1-20-ddc.pdf</u>
- If there has been a decline in skills or lack of progress, the school needs to address those gaps. There might need to be compensatory education or recovery services. *See* <u>https://webnew.ped.state.nm.us/wp-content/uploads/2020/04/Special-Education-FAQ-Final-4-1-20-ddc.pdf;</u> <u>https://cdn.ymaws.com/www.copaa.org/resource/resmgr/docs/2020\_docs/compedhandout8-13-2020.pdf</u>
- Is the school considering retaining (holding back) the student?
- Is the student receiving all of the special education instruction and related services written in the IEP, rather than an abbreviated schedule of services established during remote learning?
- Is there an initial evaluation, re-evaluation, or evaluation of a new area of concern that you have been waiting on? There has been no waiver of the timeline on evaluations (60 days after you give informed consent) and re-evaluations (every three years).
