- Introduction and Conversation with Chris Winterowd of Aging and Longterm Services Department regarding the development of another SILC partnership on education and outreach to entities who may not know about SILC.
 - Introduction to Sharon Finnerelli Executive Director, N.M. Alliance of Health Councils. Another partnership to educate and bring awareness of SILC and CILS and the role they serve in each county to the members of the Alliance of health Councils.

- Exploring the idea of establishing a Statewide Coalition CILS. Have been researching other states that have this and would like feedback from N.M CILS on the idea... The focus would be to find the commonalities between the CILS to move forward with a united voice on behalf of the disabilities community and our constituents.

- The Governor's staff has requested SILC designate a representative to sit on the State Rehabilitation Council (SRC).
 - SRC is the voice of the disabilities consumer/constituency for DVR regarding Legislative policy, advocacy, and tracking Legislative Committees both Interim and Standing Committees.
 - Discussion on who and how to approach the designation began.
 - Who meets the Criteria? Along discussion was had and Paulas Seanez recommended Petra Solimon. Before a motion was made members wanted to speak to Petra to see if she was interested. She was present and having technical difficulties. When asked she agreed.
 - A Motion was made by Paula Seanez to designate Petra Solimon as the SILC representative to SRC. It was seconded by Petra Solimon.

IX. Information Item: Quality of Life Grant: Lisa McNiven for Linnea Forsythe

- The Quality of Life Grant is available to non-profits providing service to the Disabilities Community.

X. Information Item: Covid -19 Preliminary After Action Report: Lisa McNiven,, NMDEPAC and Governors Commission on Disability.

- Report focused the disproportionate impact Covid-19 had/has on the Disabilities Community in N.M.
- Seven focus groups representing different disability groups were convened by NMDEPAC and members of the Disability Community.
- Seven Disability focus groups were established.
 - 1) Cognitive Disabilities
 - 2) Physical Disabilities
 - 3) Blind and Visually Impaired
 - 4) Mental Health Disabilities
 - 5) Deaf
 - 6) Hard of Hearing
 - 7) Deaf Blind/Oral Deaf Blind
- 51 New Mexicans with Disabilities participated from various backgrounds and regions of the State.
- The summary of the Report concludes that New Mexicans with disabilities during the pandemic highlights the tremendous need for:
 1. Reliable internet connectivity
 2. Equity and accessibility in telework and remote learning environments.
 3. Greater attention to how barriers in communication and isolation exacerbate disparities in health and wellness for people with disabilities.

XI. Discussion Item: Establishing a Statewide Coalition of CILS: SILC Coordinator Patricia Quintana

- Council and CILS Director were open to idea.
- I t was mentioned that in the past it was attempted with no follow through.

- SILC Coordinator suggested starting small by identifying the common challenges that affect all CILS and work collectively to address the challenges.
 - The longterm focuss to have a stronger more unified voice on behalf of the CILS constituency.

- Lack of internet connectivity in rural areas for Tribal Communities.
 - Lack of Adequate Transportation
- XIV. Discussion/Update Item: CILS and Covid-19: Vice-Chairwoman Coby Livingstone.
- Following CDC Guidelines.
 - Using mixed models of working from home and office.
 - Majority of meetings and services are through virtual platforms.
 - Hybrid models moving offices outdoors a couple of days a week.
 - Digital outreach approach if possible.
- XV. State Agency Quarterly Reports/Updates:
- 1) Division of Vocational Rehabilitation (DVR): Interim Director Dan Drury.
 - a. Review of attrition and vacancy rates. Overall DVR has a 20% vacancy.
 - b. RSU in Western N.M. Facilitate a boot camp for certification of Counselors. (16 enrolled)
 - c. RSA Monitoing
 - d. RSU has an 18% vacancy rate
 - e. Order of Selection and wait list
 - f. Question from Coby Livingstone regarding number of employees with disabilities. Alicia DeVargas answered. 6 of 16.
 - 2) Greg Trapp Executive Director, New Mexico Commission for the Blind.
 - a. Process in place for modification of combined state plan.
 - b. Four Public meetings planned : Thursday 10:00 am Southern N.M. ; 3:00 pm Central N.M.; Friday 10:00 am North Western N.M.; 1:00 pm northern N.M. and one more for eastern N.M.
 - c. James Salas: Hiring process for N.M. Commission for the Blind
 - d. Juan Haro: Doen 1 Independent Living Teacher(will be retiring); Blindness skills instructors needed. 2 in southern

N.M., 2 in central N.M., 1 in Farmington, 1 in Las Vegas, 1 more for Albuquerque.

- 3) Paula Seanez Executive Director, AIVRS Programs.
 - a. US Dept of Education released RSA 2021 Grant application kit. In N.M. Navajo Nation, Laguna Pueblo, and Jemez Pueblo submitted the grant application
 - b. When funding, AIVRS programs will be renegotiating MOA/MOU with NMDVR.
 - c. AIVRTTAC is in its final year of funding. Applications are due in June for 2021 .
 - d. Conference call was held with Federal RSA on March 25, 2021. It was an opportunity to get to know the new staff assigned to AIVRS Program.
 - e. The Navajo Nation has moved to the third tier (Yellow Code – moderate to low restrictions) of reopening April 25, 2021.
 - f. VR services are being provided with limited face to face contact. The VR Program staff have returned to their offices.
 - g. Tribal VR programs continue to receive professional development, technical assistance and training from AIVRTTC. The Navajo Nation OSERS program along with 3 other AIVRS programs are participating in a nine month session on employment development and placement strategies. This project creates an opportunity for capacity building among the 86 AIVRS programs.
 - h. Northwest Indian College in Washington State continues to provide college classes in rehabilitation.

XVI. CILS Reports/Updates

- 1) Sarah Michaud New Vistas.
 - a. Writing and re-writing policies during Covid.
 - b. New Vistas Up to 75% of employees back in office.
 - c. Offering incentives for employees to get vaccinated
 - d. Will celebrate 50th Anniversary in December.
 - e. Early intervention down 30%.
 - f. Currently serving 30 children.
- 2) Michael Murphy ILRC submitted report electronically. He had to leave early.
- 3) Albert Montoya The Ability Center submitted report electronically.
- 4) Audra Wilson CHOICES submitted report electronically. She had to leave meeting early.
- 5) Leslie Wright SJCI
 - a. Youth transition has attended 45 IEP meetings .

- b. Working closely with the Mental Health Center with approximately 20 referrals.
- c. During the 1st quarter there have been 61 new goals started and 28 completed.
- d. Youth program has started a Bocce Team with a goal of competing at the next Special Olympics.
- e. We continue to support the SSI application and appeal process with great success.
- f. SJCI advocated for 15 individuals in the C-Waiver process with a final approval of 5.
- g. SJCI assisted a consumer in purchasing a van that allows them to be more independent.
- h. SJCI has worked with HUD to avoid fraud and illegal fee assessment with local property management agencies.
- i. Have invited the Parkinson's and Alzheimer's group back and are hosting meetings again as well as NuMotion wheelchair clinic.
- j. SJCI is currently looking at hosting a vaccination clinic at our center.
